All prices are listed in USD and are subject to change without notice. We accept various forms of payment as indicated on the website. By submitting an order, you represent and warrant that you are authorized to use the designated payment method.

#### 2.3 Shipping and Risk of Loss

Shipping and handling fees are calculated at checkout. Shipping dates are estimates only and are not guaranteed. The risk of loss and title for all items purchased from The Studio pass to you upon our delivery to the shipping carrier.
